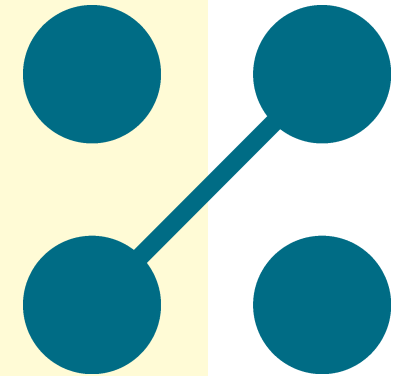

### Why Use Mediation?

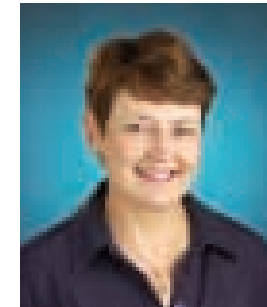
- Faster solutions
